Step 1: Have the person you are transferring your registration to fill out and sign the race registration form (found on the next page)

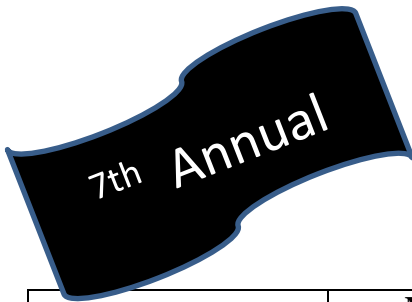
Step 2: At the top of the registration form, write: REGISTRATION TRANSFER FROM _____ (and write *your* full name)

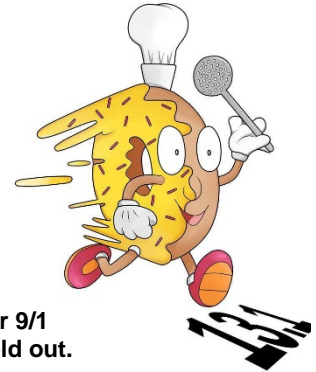
